THE MATERNITY SHELTER SERVED 70 WOMEN DURING THE CURRENT YEAR AND 25 FAMILIES WERE SERVED THROUGH THE COMMUNITY AFTER-CARE PROGRAMS. THE TRANSITIONAL APARTMENTS WERE UTILIZED BY 26 PERSONS THIS YEAR.

THE COMPREHENSIVE SERVICES OFFERED BY THE HAVEN OF GRACE ALSO INCLUDE FOOD, CASE MANAGEMENT, LIFE SKILLS EDUCATION, FINANCIAL ASSISTANCE AND MEDICAL AND MENTAL HEALTH SUPPORT.
