- * THE HAVEN (MATERNITY SHELTER) SERVED 49 WOMEN AND CHILDREN,
* THE QUAD (7 TRANSITIONAL APARTMENTS) SERVED 16 WOMEN AND CHILDREN,
* THE HAVEN DIFFERENCE (AFTERCARE SERVICES) SERVED 62 FAMILIES

COMPREHENSIVE SERVICES OFFERED BY THE HAVEN OF GRACE ALSO INCLUDE FOOD, CASE MANAGEMENT, LIFE SKILLS EDUCATION, FINANCIAL ASSISTANCE AND MEDICAL AND MENTAL HEALTH SUPPORT. UPON ENTRY TO THE ORGANIZATION, ONLY 28% OF THE WOMEN SERVED WERE EMPLOYED. AFTER PARTICIPATING IN HAVEN'S PROGRAMS, 60% FOUND EMPLOYEMENT. THROUGH HAVEN'S CASE MANAGEMENT SERVICES, 100% OF THE MOTHERS WITHOUT INSURANCE WERE ABLE TO OBTAIN IT.
